CONFERENCE FOCUS

Presenting the contribution that an Integral Green Economy and Society approach, with Slovenia as a Pilot Country, could make to a New European Renaissance in the context of the Sustainable Development Agenda.

SETTING THE SCENE

»We are meeting at a time of immense challenges to sustainable development. Billions of our citizens continue to live in poverty and are denied a life of dignity. There are rising inequalities within and among countries. There are enormous disparities of opportunity, wealth and power. Gender inequality remains a key challenge. Unemployment, particularly youth unemployment, is a major concern. Global health threats, more frequent and intense natural disasters, spiralling conflict, violent extremism, terrorism and related humanitarian crises and forced displacement of people threaten to reverse much of the development progress made in recent decades. Natural resource depletion and adverse impacts of environmental degradation, including desertification, drought, land degradation, freshwater scarcity and loss of biodiversity, add to and exacerbate the list of challenges which humanity faces. Climate change is one of the greatest challenges of our time and its adverse impacts undermine the ability of all countries to achieve sustainable development. Increases in global temperature, sea level rise, ocean acidification and other climate change impacts are seriously affecting coastal areas and low-lying coastal countries, including many least developed countries and small island developing States. The survival of many societies, and of the biological support systems of the planet, is at risk.«

This picture of the world today, complemented by the recognition that we also live in a time of immense opportunity, led the Heads of State and Government and High Representatives at Seventieth session of United Nations General Assembly in September 2015 to adopt 17 Sustainable Development Goals (SDGs) with 169 associated targets. Agenda 2030 is probably the most ambitious agenda in the history of humankind and it will have to be strongly supported by equally ambitious and integrally framed, holistic, trans-sectoral policies for sustainable development.

Urgent need for a paradigm shift is evident: for more holistic, local-global as opposed to globalizing, thereby, integrative approaches, rooted in nature and culture that are serving to improve the quality of life and welfare in general and, more specifically, enabling the sustainable development of technology and economy.

A number of integral approaches, many originating from Europe, have helped shift our global perspective towards a more integral viewpoint over the past 200 years, including that of Central Europe's Rudolf Steiner. And more recently: significant impact of US based Ken Wilber's integral approach and Don Beck's Spiral Dynamics, as well as Trans4m's Integral Worlds approach. We are witnessing an emergent "Integral Age"!

Global challenges are here and now, and in the future we can expect even more of them, with an increase in intensity and complexity. Multiple crises in Europe and neighbouring regions set in the context of a world on fire; the European Union is even facing a threat of disintegration. Among various initiatives and attempts to resurrect the grandeur of Europe are also those from which we can find inspiration in the great era of European Renaissance. Proposals and appeals for a New European Renaissance are focused on the fields of science and technology (by [EURAB in 2009](#)), and culture (e.g. [The Coming European Renaissance](#), [Europe needs a new Renaissance](#)), or more recently, on the process of democratisation; security, defence and migration issues; investments in infrastructure; monetary union and secondary education ([The Appeal of 9 May](#) in 2016). We couldn't find, however, initiatives that would incorporate an integral perspective or position themselves in the paradigm of sustainable development.

In a unique approach to fuse and upgrade these two paradigms of sustainability and integrality, a new, integral conceptual framework (the *Integral Words* paradigm) has been developed by Trans4m Center for Integral Development in Geneva, and elaborated, *inter alia*, in the realm of economy. In a unique process of co-construction, Trans4m and the Citizens' Initiative for an Integral Green Slovenia have applied this new framework within the innovation ecosystem of the European Union, on the level of individual sustainable enterprises and local communities, but also on national level, and depicted this multidimensional and multi-layered process in the new Gower and Routledge volume [Integral Green Slovenia](#) (Piciga, Schieffer and Lessem, 2016).

CONFERENCE OBJECTIVES

- Revealing the conceptual strength of the *Integral Words* paradigm for addressing global challenges
- Proposing the Integral Green Economy and Society as a possible theoretical framework for a pEuropean Renaissance on a Path of Sustainability
- Showing some potentials for Europe to reassume - now in partnership with, and drawing upon, Africa, the Middle East, Asia and America - the joint Role of Navigating together the Economic and Societal Renewal Globally
- Linking the IGS Initiative and individual cases within this initiative to EU policies and programs



- Present and Strengthen Slovenia as a Pilot Country for an Integral Green Economy and Society
- Creating a powerful co-learning, research and networking opportunity for Slovenian and international participants (from the global Trans4m network, as well as others) of the conference, with a view to future cooperation.

KEY CONFERENCE STREAMS

- Prelude: a key task is to identify the key drivers to integral renewal of the European Union, in the framework of the Sustainable Development Agenda, with special attention to the drivers and areas with large volumes of unutilized or underutilized, fragmented potentials. Such drivers will then be presented in the three main streams of the conference.
- Main Streams: in the process of co-creating an Integral Green Slovenia in the innovation ecosystem of the EU, and based on integral analysis of the present situation in Europe and beyond, the following three streams were identified as highly relevant – all containing a wealth of (unutilized) potentials:
 1. Cultural and Natural Heritage for Integral Renewal of Slovenia and Europe, In and For Community
 2. Social Knowledge-Based Economy: Strengths and Opportunities in Slovenia and Europe; a Promising Path towards SDGs
 3. Education for Sustainable Development (ESD) and for an Integral Age (EIA)

Each stream will:

- Include short presentations of relevant EU policies (strategies) and their implementation (programmes, regulations), followed by Slovenian cases
- Be enriched by relevant comparative Expertise and Contexts of Trans4m's research and enterprise community from Africa, Middle East and the UK (via the Trans4m's PhDs who will be in Slovenia for a PhD Module during the time of the conference), to contribute answers to the following questions:
 - "Integral Age" and "Societal Renaissance" emerging in other cultures: Is Europe aware of these developments?
 - Is Europe ready to support such integral impulses for societal renewal in developing countries?¹
 - Can these developments and practices help Europe to become aware of its own hidden potentials for an Integral Green Society and Economy?

All three streams will highlight important contributions for the transition to a green, low-carbon and resource efficient economy, in a view of its full integration with the social and cultural dimensions of SD.


